I am requesting funding for Augusta University (AU) in fiscal year 2025 to support the College of Science and Math for Rapid Fentanyl Detection. The entity to receive funding for this project is Augusta University, located at 1120 15th St, Augusta, GA 30912.

The funding would be used to further develop an instrument that improves current detection methods of narcotics and other substances by rapidly providing accurate data analysis to Field Operations agents without having to risk their safety. This project proposes to develop a sweep of instruments to create a Chemical Immune Border (CIB) that acts in real time to help protect first responders across-the-board. The research will be conducted and led by Dr. Guido Verbeck, who has been registered with Drug Enforcement Agency (DEA) Diversion Control for the last 14 years, and has schedule 1-5 license from DEA to work with actual drugs of abuse. This will insure that the instrument performance metrics are measured with true, not surrogate, drugs that U.S. Customs and Border Patrol (CBP) agents and first responders will encounter.

The project has a federal nexus because funding is for purposes authorized in section 272 of title 15, United States Code. Additionally, accidental exposure to opioids through the transdermal route creates a serious problem CBP agents and current technology requires large amounts of time and puts agents at risk of direct contact with these substances.
