Dear Attorney General Bondi,

I write today to respectfully urge the Department of Justice to open an investigation into the potential involvement of George Soros' Open Society Foundations in politically motivated violence and far left-extremist activities within the United States.

Since 2016, following the rise of President Donald J. Trump, our nation has witnessed a concerning escalation in politically motivated violence from far-left extremist groups. According to public reports, as of July 4, 2025, left-wing extremists were responsible for at least five separate terrorist attacks or plots, placing this year on track to become one of the most violent in recent history.¹²

One of the most tragic examples of this violence occurred on September 10, 2025, when Charlie Kirk—a patriotic American and strong advocate for free speech—was senselessly killed at Utah Valley University in an apparent act of political violence by a radical left extremist. Just weeks later, on September 24, a gunman associated with anti-ICE ideology fatally shot two detainees at a Dallas ICE field office and critically wounded another.

There is growing concern, based on credible reporting, that George Soros' Open Society Foundations have played a significant role in funding organizations associated with promoting political extremism and engage in or endorse actions that meet the Federal Bureau of Investigation's definition of domestic terrorism.³ Reports suggest the Foundation has distributed over \$80 million to groups linked to terrorism or extremist violence. Among these are the Center for Third World Organizing and the Ruckus Society, which have been tied to training in property destruction during the 2020 riots; the Sunrise Movement, which has supported campaigns tied to

Antifa-related activity; and the Movement for Black Lives, a recipient of \$18 million, which coauthored a controversial manual promoting civil disruption and, disturbingly, appeared to justify the October 7th Hamas terrorist attacks.⁴

The funding of organizations that engage in, support, or incite political violence must not be tolerated. I urge the Department of Justice to launch an immediate and comprehensive investigation into George Soros, the Open Society Foundations and their affiliates to determine whether they are in violation of any federal laws related to domestic terrorism, material support for violence, or other illegal activities targeting Americans based on political beliefs. Thank you for your attention to this serious matter. I trust the Department will treat these concerns with urgency.
